Chairman Olmstead asked everyone to stand for the recitation of the Pledge of Allegiance lead by Commissioner Charles Bishop.

ANNOUNCEMENTS:

Chairman Olmstead announced that the State of Georgia has released the funds, thus making it possible for the County to complete the construction of the addition to the DFCS building downtown. He stated that this project has been ongoing for two years and somehow during the budget crunch, the funds were lost. Now that the funds have been retrieved, they will be able to give some relief to the people at DFCS who are in such need of help and he hopes that they can get this to where it does some good for the people.

Chairman Olmstead stated that visitors would be recognized later in the meeting. However, at this time, he recognized and welcomed Mrs. Marlene Johnson, retiring Clerk of the State Court of Bibb County, for the presentation of her retirement resolution and watch.

Mrs. Johnson stated that she has enjoyed working as the Clerk of State Court for the past 30 years and that she will miss everyone at the Courthouse.

 The Committee recommends bid for Dishwashing Chemicals for the Bibb County Sheriff's Office be awarded to Georgia Correctional Industry based on the firm unit prices for the term of July 1, 2003 through June 30, 2004.

 The Committee recommends that the term contract with Staples for Office Supplies be extended at the same unit prices for the term July 1, 2003 through September 30, 2003.
